


Waiving Academic Program Application Requirements (Post-Submission)

In Slate, once applications are submitted, the application status is set to either **Awaiting Materials** or **Awaiting Decision**. The **Awaiting Materials** status is assigned if there are any missing checklist items such as official test scores and letters of recommendation. As soon as these items are all received, the application status will automatically be updated to **Awaiting Decision**. However, if your program would like to review applications with **Awaiting Materials** and manually update the application status to **Awaiting Decision**, follow the steps below.

1. Search for an applicant.




1. Click here.

2. Search for an applicant.

3. Click on an applicant's record.

2. Make sure the application has **Awaiting Materials** status, and take a look at the **Checklist** to see what application item(s) is missing. If it appears that your program has received everything you need and would like to waive some requirements for this specific applicant, click on the **Dept_Waive Req (Post-Submit)** link.



1. The Checklist will show which documents are missing.

2. Click on the **Dept_Waive Req (Post-Submit)** link.
